

Naming Opportunities Clauses

- WCHS reserves the right to withdraw a naming opportunity if it significantly impairs its reputation. In such circumstances, the organization is not obligated to return donations.
- WCHS reserves the right to withdraw or alter a naming opportunity if the agreed-upon contributions are significantly reduced. In such circumstances, the organization will make a responsible effort to work with the donor to adjust the terms of the gift and pursue other financing opportunities.
- WCHS reserves the right to ensure that all naming opportunity signage/verbiage created conforms to WCHS branding and that the design is consistent across various naming opportunities. This includes but is not limited to overall sign dimensions, phrasing/wording, color, fonts, signage materials, and placement.
- The duration of a name on any facility ordinarily continues as long as the facility is used in the same manner or for the same purpose for which the naming occurred. Upon demolition, replacement, and substantial renovation or redesignation of purpose, the organization may deem that the naming period has concluded. WCHS will make a reasonable effort to inform the donor in advance of the naming period being deemed to have concluded. WCHS may, but is not required to, provide alternative recognition of the previous name in or near new or renovated facilities.
